### Who we will share your personal data with

Your personal data is shared securely with the following organisations where it is both necessary and appropriate to do so.

#### One Education

This is a company based in Manchester that provides professional support, such as Speech and Language Therapists and Educational Psychologists, to schools and works closely with the Council. For the purposes of this project, One Education will be acting as the Council's data processor. They will use personal data to assess the effectiveness of the support they provide. Assessment will be at the pupil level and names and dates of birth will be needed together with language screening information and social, emotional, and behavioural assessment information.
